2010 Pacific Cup Player Application

The 2010 Pacific Cup competition will feature teams from San Francisco, Los Angeles, Seattle, Vancouver, Palm Springs, and San Diego. This year the event will be hosted by Team San Diego at Barnes Tennis Center on September 18-19. If you would like to be considered for the 2010 SDTF team, simply make your interest known by submitting this application.

PAC CUP DETAILS

Dates of competition: September 18-19, 2010 (SAT-SUN)

Location: San Diego, Barnes Tennis Center (hard court)

Player Qualifications:

1. Men must not have a GLTA rating higher than "B" on July 31, 2010; and must not have a USTA rating higher than NTRP 3.5 on July 31, 2010.
2. Women are allowed to compete as long as they meet the above criteria and their Women's GLTA rating is no higher than "A" on July 31, 2010.
3. Must be an official SDTF Member of Record on July 15, 2010
4. Additional Criteria used for evaluation and team selection:
 - a. GLTA Tournament Results
 - b. USTA Tournament Results

Team Captain: Frank January **Co-Captains:** George Byrd, Leonard Trinh, and Jerry Sabio

Application/Selection Process:

1. All Players interested in representing the SDTF this year in San Diego must submit this application to the Captains by **March 15, 2010**.
2. All players who submit applications will be ranked by the PAC Cup committee between April 1, 2010 and April 15, 2010 based on past experience, tournament play record, ranking, etc.
3. All players are required to participate in ladder challenge matches.
4. On June 16, 2010, the top 8 singles players and 4 doubles teams will be announced.
5. Remaining singles and doubles players will be placed in a qualifier tournament for the last 4 singles and last 2 doubles team positions. Qualifiers will be played at Balboa Tennis Center, in a format and time to be determined later based upon the number of interested, qualified members.
